

# **Background**

## **Course Offering and Description(s):**

## **CPC - Certified Professional Coder (Virtual)**

The student will learn principles of medical coding related to the three main code books: CPT®, ICD-10- CM Code Set and HCPCS Level II. This course is recommended for anyone who is preparing for a career in medical coding for a physician's office.

### **Course Objectives**

- Identify the purpose of the CPT®, ICD-10-CM, and HCPCS Level II code books
- Understand and apply the official ICD-10-CM coding guidelines
- Apply coding conventions when assigning diagnoses and procedure codes
- Identify the information in appendices of the CPT® code book
- Explain the determination of the levels of E/M services
- Code a wide variety of patient services using CPT®, ICD-10-CM, and HCPCS Level II codes
- List the major features of HCPCS Level II codes
- Provide practical application of coding operative reports and evaluation and management services

### CCMA – Clinical Certified Medical Assistant – (Virtual w/ 1 Clinical Lab per month)

The student will learn principles of what it takes to become a Certified Medical Assistant. Medical assistants (MAs) are critical members of healthcare teams in a variety of medical settings. As an MA, students are often the first and last person a patient interacts with, making a lasting impact on the patient's experience.

- Taking patient vital signs
- Assisting providers with exams and procedures
- Administering injections or medications
- Performing EKG, phlebotomy, and other essential laboratory procedures
- Checking patients in and out upon arrival and departure
- Updating and maintaining electronic health records (EHR)

  - Operating computer systems to accomplish pharmacy tasks
  - Answering calls

- Receiving prescription requests from patients and doctors' offices
- Accurately measuring medication amounts
- Establishing and maintaining patient records
- Accepting payment for prescriptions and processing insurance claims
